PRAASA 2025

Thank you, District 24, for allowing me to represent our district and showing interest in the Pacific Region and the AA Service Assembly. This year's theme, "Working Together, Increasing Trust" took place in Anchorage, Alaska. The Pacific Region includes Alaska, Arizona, California, Hawaii, Idaho, Nevada, Oregon, Utah, and Washington. We gather annually in one of these locations for panel presentations, roundtable discussions, open mic sharing, and speakers. This year we had honorary Pacific Regioners from Montana and Yukon.

My big takeaways from the event are:

- o The reduction in contributions to GSB
- o Our twelfth step
- o Taking responsibility for and committing to service in AA

The reduction in contributions to GSB –

Post-pandemic expenses have left GSB below the recommended 9–12 months of reserve. Despite discussions on financial responsibility, a simple solution is to encourage your home group treasurer to contribute online. Processing a check costs approximately \$5.00, while online processing costs \$3.00, saving \$2.00 per group each time, which can significantly help.

Our twelfth step –

The Past Trustee Panel on Sunday highlighted concerns that one-on-one support among alcoholics is becoming less common. Amidst the valuable pamphlets and literature, there's a sense of judgment towards newcomers who may not fit certain expectations. This has prompted me to rethink how I carry the message to all alcoholics, regardless of their beliefs, personality, or background.

Taking responsibility for and committing to service in AA –

Doing my part and committing to my service positions from district, to homegroup, to sponsees and my family. This topic gave me a lot to think about and reaffirmed my commitment to being responsible, anytime anywhere.

Dear Seattle area AA groups,

Since 1947 Greater Seattle Intergroup has provided a central hub for the Seattle AA community, with meeting spaces, shared information, and a central office to serve the 500-plus AA groups in the greater Seattle area in order to support you in your primary purpose of serving the alcoholic who still suffers.

Among its many services, Seattle Intergroup publishes the AA meeting guide, maintains the Seattle area AA website, staffs and runs the 24-hour phone service, runs the retail outlet for AA literature and coins, coordinates and funds Seattle area AA committee work with your contributions, provides ASL services and insurance for meetings, and holds frequent special events like the popular annual Seattle Area AA picnic.

2024 was a challenging year for Seattle Intergroup. Many area AA groups came out of the Covid epidemic with reduced budgets or added expenses, and many groups which stopped meeting have not re-started, resulting in lower than projected 7<sup>th</sup> tradition contributions. Intergroup also added some costs last year, including reopening the office on Mondays.

Seattle Intergroup was created by and for the Seattle area AA groups and primarily depends upon groups for support. We ask that groups and individuals, who can afford to help, make a contribution to Seattle Intergroup. More importantly, we ask that you get involved. Intergroup needs groups to take monthly phone answering shifts and individuals to take monthly Nightwatch phone shifts. Intergroup committees like Corrections, Hospitals & Treatment, Public Information, and Accessibility are always in need of volunteers. Please call the Intergroup office or email chair@seattleaa for more information. We are all in this together.
